

With this I hope to have raised your interest to attend the Annual General Meeting of the Swiss-Chinese Chamber of Commerce. The attendance will be free of cost for members.

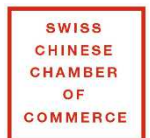
